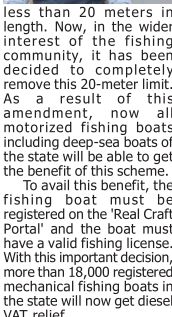

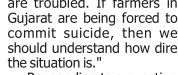

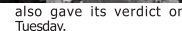

historic judgment upholding trial court's verdict

approached the High Court to affirm the death sentence and accused had approached the High Court against the lower court's verdict. On July 26, 2008, 21 serial blasts took place at 20 different locations in Ahmedabad city, killing 56 innocent people and seriously injuring over 200. It is important to note that the Ahmedabad Sessions Court sentenced the accused on Tuesday and the High Court



Amit Patel, the lawyer in this case, said that in the case of bomb blasts that took place in Ahmedabad and Surat on July 26, 2008, the trial court had earlier sentenced 38 accused to death and 11 accused to life imprisonment. The case for confirmation and appeal of this sentence was going on before the Division Bench of the Gujarat High Court, whose verdict was delivered today. The hearing of this case was going on daily from March 25th and all day from January.

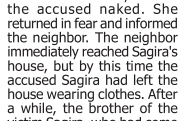
Although I have not yet studied the entire judgment as it has not been uploaded, I can tell you with certainty that the High Court has confirmed the death sentence awarded to 38 people by the trial court. In addition, the Hon'ble Court has also ordered the State Government to pay a compensation of Rs 10 lakh to the families of those who died in this incident and this amount has to be paid by 31 March 2027. At this stage, the Government side does not have to take any immediate action other than complying with this compensation order.

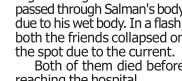

While trying to save his friend, a neighbor also died. His friend Mohammad Salman Mohammad Irshad Sheikh, 43, who lived in the same house as the man that Azam had been electrocuted and was struggling. Out of humanity and friendship, Salman ran to save Azam without a second thought. Unfortunately, as Salman tried to catch or save Azam, the deceased Salman said, "Salman is my younger brother. He lived on rent in the Libmabyat (Libmadipara) area. The house he lived in was a small house. It was a one-story house. In which my sister-in-law also got an electric shock but fortunately nothing happened to her. A neighborhood also lives next to us. We both live in the same house. It is his house. When the neighbor next door got



He further said, "In the neighbor's house and in my brother's house, there was electricity running throughout the premises. I had complained to the landlord two to three times about this, but he never took the matter seriously. He always came on time and left with the rent, but never asked what the problem was in the house. 'My brother died because of this electricity (electricity). Now the landlord is making an excuse that lightning had fallen from the sky. If lightning had fallen from the sky, the body would have been completely burnt, whereas there are no such scars or signs of burning on my brother's body.'"

When Rander police was informed about this whole matter, a police convoy rushed to the spot and the hospital. Initially, it has been revealed that this was an incident of electrocution, but there was also discussion at the local level that since there were heavy explosions in the sky in the evening, this accident may have been caused by lightning. According to police sources, a case of accidental death has been registered and further investigation is under way. The real reasons for the death of both will be clear only after the postmortem report comes. Currently, the bodies of both have been sent for postmortem and further legal action has been taken.
